## MINUTES OF BOARD OF ASSESSORS' MEETING MARCH 15, 2022

William Garreffi, Chairman called the Session to order at 4:45 p.m.in the Selectmen's Conference Room. In attendance was William Garreffi - Chairman; Melvin Pauze - Board Member; R. Lane Partridge - Director and Lisa Henderson - Clerk.

PUBLIC COMMENT: None

DIRECTOR UPDATE: We are continuing with abatements and it is going well. We are also in the process of filling our Administrative grade 8 position. We still have approximately eight weeks before our injured field inspector can come back to work and in the mean time we have hired two temporary field inspectors to help us get caught up through the end of the fiscal year. Motor vehicle commitment #2 has just come in and has yet to be processed. Other staff has been collaborating and helping out during our staffing shortage including working on getting our Income & Expense mailing out which is a big undertaking.

## **NEW BUSINESS:**

Director Partridge explained and discussed the Verizon Agreement to the Board. Since Verizon is viewed somewhat as a monopoly and control all the land lines and was given a valuation by the Department of Revenue. Approximately 18 years ago the Department of Revenue changed the way they were valued which unsettled Verizon. This change prompted Verizon to file abatements across the State in almost every community. With so many communities across the State have a back log of several years of abatements, the Assessors Association stepped in and forced the issue by filing abatements of our own against the Department of Revenue on this matter with the Appellate Tax Board. This pushed everyone to the table to negotiate an agreement on how Verizon is valued. That agreement has come due again which is on methodology, modern value and what the depreciation would be.

The Board discussed accepting the Verizon Agreement as presented by Director Partridge. There was a motion and a second to accept the Verizon Agreement as presented by Director Partridge. Vote was by MAJORITY to APPROVE the Verizon Agreement as presented by Director Partridge.
