NEW BUSINESS

1. Special One Day Alcohol & Entertainment License – Temporary Extension of Premise

An application was submitted by Hyannis West End LLC dba The West End, 20 Scudder Avenue, Hyannis to hold ***Cheekie Schoolie Tourament***, a Captain's Meeting, on May 19, 2023 from 4pm to 11pm. Alcohol will be poured by The West End; Entertainment to include recorded music as well as Live, non-amplified, guitar and singing.

2. Special One Day Alcohol & Entertainment License – Temporary Extension of Premise

An application was submitted by Hyannis West End LLC dba The West End, 20 Scudder Avenue, Hyannis to hold ***Cheekie Schoolie Tourament***, Awards Ceremony, on May 20, 2023 from 3pm to 11pm. Alcohol will be poured by The West End; Entertainment to include recorded music as well as Live, non-amplified, guitar and singing.

3. Special One Day Beer & Wine, and Entertainment License

6. Amend Class II Auto Dealer License

Cape Codder Acquisition Corp. dba *Copeland Chevrolet Hyannis*, 22 Ridgewood Avenue, Hyannis, for an alteration of premises with respects to the existing Class II Auto Dealer License. The applicant proposes to expand into the former Copeland Subaru location. New description of premises is as follows: **20 (including 22, 24, 25 & 58) Ridgewood Avenue, Hyannis; 288 total spaces; 71 customer spaces, 136 display spaces, 67 employee spaces, 5 handicap spaces, and 9 showroom spaces.**

7. Annual All Alcohol License – Change of License Type

The Mill Street Tavern dba *Cape Cod Inn/Duck Inn Pub*, 447 Main Street, Hyannis for a change of license type from restaurant to general on-premise.

8. New Daily Live & Daily Non-Live Entertainment

Kami Perry dba *Perry-Lima Cafe*, 575 Main Street, Hyannis for a new Daily Live and new Daily Non-Live Entertainment license. Daily Live Entertainment to include live amplified music with 5 performers and 8 pieces. Proposed Daily Live hours are Monday – Saturday 5pm to 10pm and Sundays, 1pm – 10pm. Daily Non-Live Entertainment to include 2 TV's and recorded music below conversation level. Proposed Daily Non-Live hours are daily from 10am to 10pm.

9. New Annual All Alcohol and Daily Non-Live Entertainment

Nonno Pizza Inc dba *Nonno Pizza*, 640 Main Street, Hyannis for a new Annual All Alcohol Common Victualler and a Daily Non-Live Entertainment license. Hours of operation to remain Monday through Sunday 11:30am to 10pm. The proposed manager is Maximiliano de Paula. Daily Non-Live Entertainment to include recorded music below conversation level and 6 TV's. Noting the following premise description: **Wood frame structure with a first floor restaurant facility and basement (2750 sqft) for storage. Premise consists of one entrance and three exits, 16 bar seats, 84 table seats, for a total of 100 seats, two handicap accessible restrooms, a kitchen, cold chamber and walk-in cooler.**

10. New Annual All Alcohol, Daily Live and Daily Non-Live Entertainment

Across the Harbor, Inc. dba *Tides on Ocean Street*, 235 Ocean Street, Hyannis for a new Annual All Alcohol Common Victualler license, Daily Live Entertainment and Daily Non-Live Entertainment. Daily hours of operation are Monday through Saturday 8AM to 1AM, Sunday 12PM-12AM. The proposed manager is William J. Goodwin.

Premise Description: Wood structure with first floor dining room with 30 seats, bar with 29 seats and outdoor patio with 40 seats' 2 handicap accessible bathrooms and 2 exits on the first floor with kitchen, service area, and three rooms off the back on of the premise used for alcohol storage, ice machines, and cooler; seating 99, 9 standees, 14 employees, for a total occupancy of 127 on first floor (first floor totaling 1940 sqft including patio); second floor is 1636 sqft (1037 sqft dining room, 72 sqft storage and 525 sqft deck); there are 109 seats, 20 standees, and 10 employees for a second floor occupancy of 129. Total seating for entire premises is 208.

Daily Live Entertainment to include live amplified music; a total of 5 performers; 3 performers on the 1st floor and 2 performers on the 2nd floor. Daily Non-Live Entertainment includes a jukebox, 8 TV's, and recorded music below conversation level. Hours of Entertainment are Monday – Saturday 10AM to 12:45AM, Sunday 12PM to 12AM

SHOW CAUSE HEARING

Annual Class II Auto Dealer License for J&J Auto, 381 Camp Street, Hyannis for the following violations of the Town of Barnstable, MA Code:

501-5 (b) License holders are required to attend any and all mandatory meetings held by the Licensing Division or any Town of Barnstable Division as related to the business operation.

509-2 (c) A sign is required on the property, whether it is a free standing sign or displayed in the door or window, listing the name of the business and hours of operation.

509-4 (c) Total vehicle count shall include the numbers of displayed/unregistered vehicles, customer vehicles, including spaces Handicap accessibility, and employee vehicles. The plan shall be approved by the Building Commissioner and Fire Department. This shall apply to all new, transferred or amend license applications.

509-4 (e) Motor vehicles for sale or lease may not be displayed less than 10 feet from property line.

509-5 (c) Expansion of that portion of the premise occupied by the licensee to be designated or devoted to the licensed activity beyond the boundaries designated and highlighted in the plan submitted with the original application.

For your information the section of the M.G.L. that pertains to postings of meetings is as follows: Except in an emergency, in addition to any notice otherwise required by law, a public body shall post notice of every meeting at least 48 hours prior to such meeting, excluding Saturdays, Sundays and legal holidays. In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. Meetings of a local public body, notice shall be filed with the municipal clerk, and posted in a manner conspicuously visible to the public at all hours
