A meeting of the Barnstable Licensing Authority was held on Monday, December 14, 2020. David Nunheimer, Commissioner called the meeting in order at 9:30am. He introduced Mr. Richard Scali, Director of Licensing to explain how this zoom meeting will work and introduced all the participants. Mr. Scali introduced Commissioner, Mr. Larry Decker, Associate Commissioner, Ms. Nancy Karlson-Lidman and Associate Commissioner, Mr. David Hirsch. Also, in attendance were Officer Therese Gallant and Licensing Assistant, Lindsay Parvin. Lt. John Murphy and Chairman, Mr. Martin Hoxie were absent.

Vote to accept Minutes:

1. Vote to accept minutes of the November 9, 2020 hearing.

A motion was duly made by Mr. Decker, seconded by Mr. Hirsch and a unanimous vote was taken to accept the minutes of the 11/9/2020 meeting as printed.

New Business:

1. **Consent Agenda:**

Mr. Decker asked if the Naked Oyster is required to pay their renewal fee despite requesting to temporarily close.

Mr. Scali stated that they will need to pay and submit renewal paperwork. He noted that establishments received a credit based on their 2020 length of closure. Establishments that have not been able to open in any capacity due to the Governors restrictions will be required to pay the renewal fee before resuming operations. He will have a discussion with Building Commissioner, Brian Florence regarding the establishments with pending State Safety certifications.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to accept the minutes of the 11/9/2020 meeting as printed.

Public Hearings:

1. **APPLICATION FOR A NEW ANNUAL COMMON VICTUALLER LICENSE AND OUTDOOR:**

Application of TSC of Hyannis, Inc. d/b/a Tropical Smoothie Cafe, 489 Bearses Way, Hyannis, Connie R. Medeiros, Manager, for a new Annual Common Victualler License, to be operated 7:00 am to 10:00 pm, daily. The seating is for a maximum of 71 seats; 55 interior seats and 16 outdoor patio seats, as approved by the Building Commissioner on November 4, 2020. This license was previously under the corporation name GCMB Enterprises, Inc.

Connie Medeiros and Matthew Medeiros appeared on behalf of the application. Ms. Medeiros took over ownership from her sister and as a result created a new entity. She has been managing the establishment since 2016 and is not making any changes to the floor plan or daily operations of the business.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to approve the application as presented.

2. APPLICATION TO AMEND CLASS II AUTO DEALER LICENSE TO A NEW CORPORATE NAME:

Application of Beard Automotive LLC d/b/a Beard Automotive, 92 Rosary Lane, Unit 16, Hyannis, Gary Beard, Manager, for amendments to an existing Class II Auto Dealer License. Amendment is to change the corporation name from Beard Motors, Inc. to Beard Automotive LLC. No other changes are requested at this time.

Gary Beard appeared on behalf of the application. Mr. Beard stated that his accountant advised that he dissolve his former corporations before the end of the year. He notes that nothing will change in terms of business operations or site layout. Nothing has changed other than the corporate name.

Mr. Decker noted that Building Commissioner, Brian Florence requested an engineered site survey be submitted for approval within 90 days.

Mr. Beard stated that he tried to contact Brian Florence for clarification but was unable to reach him. Mr. Beard was confused as to why the hand drawn plan was sufficient for filing two years ago.

Mr. Scali informed the applicant that Mr. Florence has since instituted the requirement of the submitting of an engineered plan from each applicant upon transfer.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to approve the application subject to the clarification of the property survey.

3. APPLICATION FOR CHANGE OF MANAGER ON AN ANNUAL ALL ALCOHOL COMMON VICTUALLER LICENSE:

Application of Shenanigans Inc. d/b/a Bobby Byrne's Hyannis Pub, 489 Bearses Way, Hyannis on their Annual All Alcohol Common Victualler License, for a Change of Manager from Fiona M. Slattery to Robert Klock.

Robert Klock appeared on behalf of the application. He stated that he has been with Bobby Byrnes for 25 years. He was manager at the Hyannis location for 3-4 years prior to being transferred him to the Sandwich location. The company has requested that he return to the Hyannis location.

Mr. Decker noted that he Mr. Klock resides off-cape. He asked whether Mr. Klock would have difficulty with the distance from the establishment.

Mr. Klock stated that he has been commuting to various Bobby Byrnes locations throughout the Cape for 25 years and is not bothered by the commute.

Mr. Scali asked Mr. Klock how the restaurant has been managing the capacity restrictions pertaining to the pandemic.

Mr. Klock stated that tables has been placed alongside the bar area, separated six feet from the adjacent table.

Ms. Karlson-Lidman asked if Mr. Klock knew the total capacity of the establishment.

Mr. Klock stated that the total capacity is 150 and they are currently adhering to the 40% capacity restrictions.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to approve the application as presented.

4. APPLICATION FOR CHANGE OF MANAGER ON AN ANNUAL ALL ALCOHOL COMMON VICTUALLER LICENSE

Application of Not Your Average Joe's Inc. d/b/a Not Your Average Joe's, 793 Iyannough Road, Hyannis on their Annual All Alcohol Common Victualler License, for a Change of Manager from Sean McDaniel to Daniel Truesdale.

Daniel Truesdale appeared on behalf of the application. Mr. Truesdale stated that the former manager has left the company. Mr. Truesdale was transferred to the Hyannis location to oversee the reopening following an extensive remodel. He has since been promoted to manager.

Mr. Scali asked Mr. Truesdale how the floor plan has been modified as a result of the covid-19 capacity restrictions.

Mr. Truesdale stated that the establishment has been following all of the Governor mandates and are currently operating at a 40% capacity (72.3 seats). The installed plexi glass dividers at the bar.

Paul Logan, Cotuit resident and member of the Disability Commission spoke in opposition to the application. Mr. Logan stated that the Not Your Average Joes Change of Manager request should not move forward until Not Your Average Joes corrects an out of compliance order as they are violating State law by not provided accessibility in all dining areas.

Mr. Logan stated that 13 months following an extensive renovation the establishment has yet to provide accessibility to all dining areas within the restaurant. He has raised this issue to the Chair of Not Your Average Joes as well as the Town of Barnstable. He does not believe the

company should be allowed to continue to operate while in violation of State law. Mr. Logan stated that as a person in a wheelchair, he feels totally discriminated by the establishment. He stated that there are no accessible tables in the bar area of the restaurant which violates several sections of the Massachusetts Architectural Access Laws as well as Section 17.2 of MGL, 21 CMR which states that all dining areas must be accessible.

Mr. Nunheimer asked Mr. Truesdale if there has been any discussion within the company to address the issues raised by Mr. Logan.

Mr. Truesdale stated that he is aware of conversations between Mr. Logan and the President/CEO as well the CFO. It is his understanding that the renovations and current floor plan had been properly approved.

Mr. Nunheimer asked if a Building permit has been issued for the renovations.

Mr. Truesdale stated that a Building permit was issued for the recent renovations.

Mr. Scali stated that he has previously discussed the matter with Mr. Logan as well as Building Commissioner, Brian Florence but will need to obtain an update from Mr. Florence as he is the approving authority in regards to this matter.

Mr. Logan urged the Town of Barnstable to act in resolving this violation which has gone on 13 months. He noted that all that is needed to satisfy the requirement is one accessible table to be placed in the bar area.

Mr. Decker asked Mr. Scali if the Change of Manager Application may proceed as it is necessary to have a manager in place to oversee business operations. He requested to be updated at the December 30, 2020 meeting in regards to the issue raised by Mr. Logan.

Mr. Scali advised that the matter be placed on the December 30, 2020 agenda for review. In the meantime he will discuss the matter with Mr. Florence.

Mr. Nunheimer agrees that the Change of Manager application should not be withheld and strongly suggests that they revisit the complaint at the December 30, 2020 Licensing hearing, pending an update from Brian Florence, Building Commissioner.

A motion was duly made by Mr. Nunheimer, seconded by Ms. Decker and a unanimous vote was taken to approve the application as presented

5. APPLICATION FOR A TRANSFER OF AN ANNUAL WINE AND MALT RETAIL PACKAGE GOODS STORE

Application to transfer the Annual Wine and Malt Retail Package Goods Store License from Willow Tree Market Inc., d/b/a Willow Tree Market, Saeed Chaudhry, Manager, 15 Charles Street, Hyannis to Sher Corporation, d/b/a Willow Tree Market, Raheel A. Chaudhry, Manager, 15 Charles Street, Hyannis.

Description of Premise: Southerly side of Charles Street, 1 ½ story wood frame building, with drive thru window, approximately 2,800 square feet, with grocery racks, walk in cooler, lavatories, with entrances on front (right) and rear. Hours of Operation: M-Saturday, 8:00 am to 11:00 pm; Sundays, 10:00 am to 11:00pm.

Attorney Paul Tardiff appeared on behalf of the application along with the current owner and applicant, Raheel Chaudhry. Attorney Tardiff stated that a completed application has been submitted. The applicant is a United States citizen over the age of 21. He has completed the alcohol sales certification course.

Attorney Tardiff noted that the property is unique in that it has a drive-thru window. As stipulated on the existing license, the drive-thru window will not be used for alcohol sales.

Attorney Tardiff stated that the property has an extensive security system with 16 cameras and a state-of-the art Identification check system. The requested hours of operation are: M-Saturday, 8:00 am to 11:00 pm; Sundays, 10:00 am to 11:00pm, noting that the business has been closing at 9:30pm due to the current covid-19 restrictions.

Attorney Tardiff stated that the transfer is between family members. Current owner, Mr. Saeed Chaudhry is a much respected businessman throughout the Cape and it is the intention for his son to take over the location. The applicant has gained much experience while working in his father's business locations throughout the years and looks forward to the opportunity.

Mr. Decker asked for clarification of the operating hours.

Attorney Tardiff stated that the store opens at 7:00am but alcohol sales will commence at 8:00am.

Disability Commission Member, Paul Logan asked the applicant to consider moving the handicapped parking sign so that it is directly in front on the handicapped parking space.

Mr. Scali asked the applicant to explain his methods in prohibiting alcohol sales to minors.

Mr. Chaudhry stated that they are very vigilant in checking identification and the staff is trained regularly in identifying false ID's.

Mr. Scali noted that the lower sale price is indicative of a transfer between family members. Mr. Scali advised the applicant to contact the Health Division regarding the Tobacco license.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to approve the application as presented.

1. SHOW CAUSE HEARING:

The Barnstable Licensing Authority will hold a Show Cause Hearing relative to the Lodging House License for the Sea Beach Inn Co. d/b/a Sea Beach Inn, 388 Sea Street, Hyannis, Catherine Darling, Manager, for the following violations of the Town of Barnstable Rules and Regulations: Section 501-9 Physical Premises (subsection b), 501-11 Environs of Licensed Premises (subsection f) and 501-14 Other Causes for Revocation, Suspension and Modification of the Town of Barnstable Rules and Regulations (subsection b).***Continued from 8/17/2020 hearing***

Consumer Affairs Officer, Therese M. Gallant requested a continuance in order to examine court documents and case files related to the recent dismissals of cases related to the property. Officer Gallant stated that there is a pattern of similar complaints filed against multiple tenants. She would like to have a conversation with Ms. Darling and her Attorney regarding the increased request for police assistance at the property and come up with a solution.

Mr. Nunheimer asked for a summary of the dismissed charges.

Officer Gallant stated that the charges relate to larceny and breaking and entering. Officer Gallant noted that there has been a significant increase in service calls to the address since Ms. Darling assumed ownership. She has filed for harassment protect order against 3 of her tenants.

A motion was duly made by Mr. Decker, seconded by Ms. Karlson-Lidman and a unanimous vote was taken to continue the matter to the December 30, 2020 Licensing hearing.

Licensing Division Updates:

1. Licensing Department updates

Mr. Scali stated that the department continues to work on renewals. The majority of renewals are on today's agenda. The remaining renewals will appear on the December 30, 2020 agenda. If a Licensee is unable to pay the required fee by December 31, 2020 we have advised that they put their concerns in writing and it will be reviewed by the Board on a case by case basis. He noted that the department no longer accepts half payments. He will continue to update licensees on changes to Covid-19 protocols and restrictions based on the Governor's directives. Mr. Scali noted that a new Licensing Board member has been appointed but there are legal conflict of interest concerns as he owns two licensed businesses in town. The 19th Hole was allegedly found to be in violation of covid-19 restrictions. The ABCC Hearing is scheduled for December 21, 2020. The Garrett's appeal is also scheduled to be heard by the ABCC this week. Ms. Karlson-Lidman is prepared to testify.




