A quorum being met, Chair Richard called the hearing to order at 6:30 pm. The Chair explained the hearing and appeal process and invited the public to address the Committee and view the plans of interest when the application is called.

Chair Richard called the meeting to order at 6:30 pm and took roll call.

CONTINUED APPLICATIONS

Diocese of Fall River, 4 Parker Road, West Barnstable, Map 197 Parcel 005/000, built c. 1920. Our Lady of Hope Catholic Church Built c. 1920, contributing structure in the Old King's Highway Historic District.

To remove existing slate roof and replace with new asphalt shingle roof.

The applicant requested that the application be withdrawn.

There was no public comment.

Reardon, Paul, 94 Country Club Drive, Map 350 Parcel 019/000, built c. 1983.

To strip wood clapboard and replace with vinyl clapboard on front façade only.

There was no representation.

The Chair determined that this application did not require representation as approval was continued after members had the opportunity to review the siding sample.

Discussion:

The members had reviewed the sample.

Clerk McCarthy noted that although that the product is vinyl, from a distance it would simulate wood graining and appears to be wood.

Chair Richard commented that the material is not shiny. The area does include other approved vinyl siding. He believes that this is appropriate for the location.

There was a motion made by Clerk McCarthy to approve the certificate of appropriateness as submitted for Paul Reardon at 94 Country Club Drive, Map 350 Parcel 019/000 and built c. 1983 for to strip wood clapboard and replace with vinyl clapboard on front façade only.

Nagle, Donna, 3219 Main Street, Barnstable, Map 299 Parcel 023/001, built c. 1920, Freeman's Friendly Service. Contributing structure within the Old King's Highway Historic District.

To remove and replace signage.

The applicant requested that the item was continued to the March 9, 2022 meeting.

The application was represented by Michelle Aceto and Celeste Howe.

Discussion:

Clerk McCarthy and Member Wallace commented that the change was appropriate.

Chair Richard noted that the road is not heavily travelled. He noted that the window material is like for like to the existing main structure. The roof shingles will also match the shingles on the existing main structure.

There was a motion made by Clerk McCarthy to approved the Certificate of Appropriateness as submitted for Celeste Howe and Michelle Aceto for 33 Captain Murphy's Way, Barnstable, Map 317 Parcel 031-01C, and built c. 2006 to convert a garage to a living space to include replacing the garage door with doors and windows and the addition of exterior lighting fixtures.

MINOR MODIFICATIONS

Johnson, Courtney 3915 Main Street, Barnstable, Map 335 Parcel 051/000, built c. 1745.

Contributing building in the Old King's Highway Historic District.

To replace the rear slider with a French door with fixed simulated divided lites for grille pattern.

There was no representation present nor is it required.

Discussion:

Chair Richard noted that this was not a highly visible modification and is appropriate.

All members agreed this was an appropriate modification.

The motion was made by Clerk McCarthy to approved the minor modification as submitted for Johnson, Courtney Johnson at 3915 Main Street, Barnstable, Map 335 Parcel 051/000, and built c. 1745 which is a contributing building in the Old King's Highway Historic District to replace the rear slider with a French door with fixed simulated divided lites for grille pattern.

The majority of changes were for grammar and increasing the appeal fee from \$100.00 to \$200.00.
