

## Town Council Meeting August 15, 2024



A quorum being duly present, Vice President Craig Tamash called the August 15, 2024, Town Council meeting to order at 6:14 PM.

An announcement was made by Vice President Tamash regarding the meeting being televised live and questioning if anyone was actively taping the session to please make their presence known. This session is recorded and broadcast on Channel 8 or Channel 1072.

Vice President Tamash invited veteran Bob Jones to the podium to lead the Pledge of Allegiance, followed by a moment of silence to remember Lucien Poyant, Marilyn Fifield, George Jessop, Jr. and those close to you.

Vice President Tamash announced that Town Manager Ells was withdrawing Item No. 2025-006, which was an appropriation request for funding for outside counsel to assist the Town in opposing the New England Wind 2 (formerly, Commonwealth Wind) offshore renewable wind project proposed to land at Dowses Beach. Town Manager Ells confirmed that he was withdrawing that item, and Vice President Tamash announced the item was withdrawn.

Vice President Tamash then announced that Paul Phalan had asked to have his nomination to the Airport Commission withdrawn and said that there would be some procedural motions to remove Mr. Phalan from that item later in the evening.

### **PUBLIC COMMENT:**

### In-Person:

Debra Aguiar a non-spokesperson of United Sovern Americans, stated the numbers of voters using only official data, by city and town clerks may not have been accurate. Asking that the Town Council listen to the resolution and vote promptly.

Laura Mitchell a non-spokesperson of United Sovern Americans read a part of the resolution, that voter rolls must be accurate, votes counted must be from eligible voters, and the number of votes counted must be equal to the number of voters.

Phyllis Sprout a non-spokesperson of United Sovern Americans state we must provide relief to the people, proof of citizenship, voter rolls certified accurate and available for public review prior to voting.

Virginia Apel a non-spokesperson of United Sovern Americans wants hand marked secure ballots, like currency. Where imaging technology is used for tabulation, must have verifiable ballot images

William Winters a non-spokesperson of United Sovern Americans stated you need to be responsive to what we have found. You have a chance to pass these proactive resolutions to support of the 2024 elections. (Exhibit A)

Rick Brigham has been exploring the elections process, and discovered how complicated the rules are for elections. Would like to have one or two Councilors join him in asking procedural questions of the Registry of Motor Vehicles, regarding citizenships questions.

Andrew Bonney, CEO of Cape Air, one of the largest commuter airlines in the world is based at Cape Cod Gateway Airport. We are dependent on the facilities at Cape Cod Gateway Airport. Thanked the Council for their support.

Susan Batista stated residents of 525 South Street, graduates of the Riverview School, are thriving and working in the Hyannis Community. She commended the walkability allows the graduates to travel independently. Speaking in support of Great Streets, the plan has been delayed, we have had a lot of close calls on South Street due to traffic and unsafe crosswalks

Van talked about the safety issues at the unsafe crosswalk in his neighborhood. If the people could park halfway up the block, it could make a difference. Move the crosswalk a little further up the street.

Ava Klaetke lives at 525 South Street every time a dart bus goes by, they can't see the cars speeding by.

Fritz Klaetke, Ava's dad, this is a real critical safety issue in our town, we have done the study, it has been approved it is time to move forward.

Dianne Dupuis a transitional employment manager for the Clean Team program, said her concerns are for the safety of crosswalks on Main Street, spoke about the 2023 fatal accident between a person and a motor vehicle that occurred on Main Street. We can make Main Street safer for everyone.

Mark Onorato, Director of Aviation Operations was in support of Cape Cod Gateway Airport for Boston Med Flight. We routinely use the Cape Cod Gateway Airport, as the closest and safest for our helicopters to land and we utilize the fuel available at the airport. The concept of using the Joint Base Cape Cod is not viable, lives depend on a thriving Cape Cod Gateway Airport.

Norm Weill current Airport Commissioner, talked about the Airport as an asset of the community, provides for high value jobs, and is an economic development engine. The Commission needs diverse people on it, we have a variety of backgrounds. The management is second to none, very proactive. What you vote on and what you say impacts the value of the Airport.

Vice President Tamash, explained one of our Town Council members may have to leave due to a family emergency. Please keep your comments short and succinct, please.

Wendy Bierwirth discussed the Cape Cod Gateway Airport. She felt this is an asset for the Town of Barnstable and its residents.

Susanne Conley Save Greater Dowses Beach, spoke with Governor Healy about the cable landings, that there are much better options available. She remined her that she fought very

hard to protect our article 97 land, do not buy into the myth that your hands are tied. There should be no price tag on the Town of Barnstable.

Conrad Watson spoke about the safety issue at the intersection of Main Street. The big problems are the lights, the speeding vehicles and the crosswalks.

Matt Clark owns the property at 252 Main Street, have seen three people get hit by cars, and close calls. Try to move this forward as a safety issue and invest in this part of town, continue to improve this end of Main Street, invite development.

Elizabeth Wurfbain supported the Great Streets plan, stating she is overwhelmingly in favor of safety. Change is hard, it looks busy when you have a two way Main Street. Main Street Hyannis is the busiest commercial corridor on Cape Cod.

Bruce Prescot, please implement the Great Streets project.

Cheryl Powell spoke about her sister who was an addict and had mental health issues. She continued with what it takes to care for the people who have mental health issues and addictions. Project for the Opioid funds is very important. She ended with a quote from Stephen King.

Paul Phalan thanked the nomination committee, decided to withdraw his application, I am not a cheerleader, I am a spokesperson for the town. The lack of transparency, this isn't a closure it's a merger. It is an opportunity to use Cape Cod Gateway Airport property.
